**In order to receive a voucher for a rebate, you will need to meet the following criteria:**

- Purchased appliance (Furnace, Heat Pump, Hot Water Heater, Refrigerator, Dishwasher, and Washing Machine) must be an ENERGY STAR qualified appliance.
- Furnace equipment must be installed by a licensed HVAC contractor.
- Dishwasher/Hot Water Heater appliance must be installed by a licensed plumber and/or licensed electrician.
- Old appliances must be lawfully recycled by contractor and/or vendor.

**If you meet the required criteria take the following steps:**

- [Download and complete application](#) then submit and attach required Income documentation along with proof of homeownership (i.e. copies of tax statement or mortgage statement) as requested.

- Mail completed application to: Oregon Housing and Community Services (OHCS), Attn: Energy Unit – Appliance Replacement Program, 725 Summer St NE, Suite B, Salem, Oregon 97301; or Fax: (503) 986-2006.

**Review process upon receipt of your application:**

- OHCS will review and mail voucher or respond within two weeks of receipt of application. If there are any questions or clarification needed, you may receive a call for additional information.
- You must purchase, install, and redeem voucher within 90 days of issue (date will be included in voucher). You will need to submit a receipt of invoice detailing appliance model and proper recycling of old appliance when redeeming your voucher.
