54 THE HEARINGS OFFICER: My name is Tim Zimmer, and I will be serving as the  
55 Oregon Housing and Community Services Hearing Officer. The purpose of this hearing is to take  
56 public comment on the 2011-2012 Oregon Weatherization Assistance Program State Plan. There  
57 have been copies of the document placed on the table near the attendance sign-in.

59 This hearing will be tape recorded and transcribed into public record.  
60

61 No responses to questions will be made at this time. The agency will review issues  
62 raised during the public comment period, and the hearing officer's report will contain responses.

65 In addition to presenting oral comments at this hearing, anyone may submit written  
66 comments until 5:00pm, January 24, 2011, which is the close of public comment period. Comments  
67 received after that time will be reviewed or considered by the agency unless the agency decides to  
68 extend the public comment period for everyone.

70 Each person attending this hearing or wishing to comment orally at this hearing should  
71 sign in at the door. I will use the attendance list to call each person who indicates they'd like to testify.  
72 When I call your name, please come forward, state your name and address. If you represent and  
73 organization, please state the name. You may then present your comments. If you have a written, If  
74 you have written material to enter into the record, please say so and summarize it briefly. Please  
75 provide a copy of the material if you have not already submitted it to the agency.

78 I will begin the hearing in about five minutes to give you an opportunity to sign the  
attendance sheet. If you have any questions or how the hearing will be conducted, please ask.

81 THE HEARINGS OFFICER: This hearing is now in session and being recorded to  
82 maintain a permanent record. My name is Tim Zimmer and I am the hearing officer. Today is January

85 The purpose of this hearing is to provide and opportunity for public comment on the  
86 rules proposed for the 2011-2012 Weatherization Assistance Program State Plan by Oregon Housing  
87 and Community Services.

90 comments until January 24, 2011 at 5:00pm which is the close of public comment period. Comments

96 responses. This report, along with a transcription of the public hearings, will be attached to the State  
97 Plan submitted to the US Department of Energy.

100 public can request a copy of this document at any time.
